Dear Brothers and Sisters in Christ:

I am pleased to write this letter to accompany the publication of the Ukrainian Catholic Eparchy of Saint Josaphat in Parma's financial statements for 2016.

Since 2011, the Eparchy has had its finances audited each year by the independent accounting firm of Simic CPA & Co. Since 2013, the Eparchy has published its financial statements online and distributed the statements to all of its parishes. Included with the financial statements is a letter from Father Steven Paliwoda, the Eparchy's Financial Officer, explaining the statements in detail. I encourage you to read Father Steven's letter in conjunction with the financial statements. The Eparchy is amongst the most transparent Catholic dioceses in the world.

Just as it is important for the Eparchy to be transparent about its finances, **I encourage every parish in the Eparchy to do the same: be transparent in its finances and accountable to the faithful, whom the Church exists to serve.**

There is much good news to report about the financial state of the Eparchy in 2016. Here are several highlights.

- ✓ The Eparchy's Financial Situation Has Recovered Dramatically Over the Past Five Years. In 2011, the Eparchy was \$1 million in debt, a year behind in its property insurance premiums, and going deeper into debt every year. That year, Bishop John Bura created a Stewardship Office to help the Eparchy with its finances. Within five years, the Eparchy experienced a dramatic turnaround: In 2016, the Eparchy finished paying its entire external debt, caught up on all insurance payments, and started a small endowment fund to secure our financial future. This is all thanks to YOUR generosity. Thank you!
- ✓ Support from Foundations. Thanks to the efforts of the Stewardship Office, the Eparchy receives over \$300,000 in grants each year from wonderful friends like Catholic Home Missions, Catholic Extension Society, Our Sunday Visitor Institute, the Heritage Foundation of First Security Federal Savings Bank, the ACTA Foundation and the Koch Foundation. I am hopeful that the Stewardship Office will continue to produce excellent results in the future.
- ✓ Reducing Expenses, Other Steps Being Taken. We continue to do everything possible to be efficient and cut expenses. All nonessential expenses and noncritical repairs are delayed until we have raised the funds to pay for those repairs.

- ✓ Important Ministries Expanded. We continued to invest in 2016 in our most important ministries such as Youth Ministry, which helps children grow closer to Christ. This is so important, as the children of today will be parents bringing their children to our churches tomorrow. We also started ongoing formation programs for priests, deacons and their wives in 2016, and we will begin a ministry for Family and Sanctity of Life in 2017.
- ✓ New Mission Opened. In 2016, the Eparchy opened a mission (new parish) in Pineville, NC, and we sent young priests to several more missions. These are critical for reaching out to Ukrainian Catholics who would otherwise not be able to worship in a Ukrainian Catholic parish. There are still several communities in the Eparchy where the people are clamoring for the Sacraments, such as Columbia, SC, Charleston, SC; and Augusta, GA. I hope we can open missions in these places in the near future to serve these good people.

**Brothers and Sisters, the future of the Eparchy depends upon the financial support that you give to it. I ask you to be generous in every way possible, including by remembering the Eparchy in your last will and testament, or as the beneficiary of an insurance policy or Individual Retirement Account. You can also start a Catholic Gift Annuity, which offers tax advantages. Please consider these and other ways to support your Eparchy.**
